ASTD Tallahassee Chapter reserves the right at any time after receipt of your order, without prior notice to you, to supply less than the quantity you ordered of any item. All orders placed over \$2000.00 (U.S.) must obtain pre-approval with an acceptable method of payment, as established by our finance department. We may require additional verifications or information before accepting any order.

## ***16. Delivery Policy***

ASTD Tallahassee Chapter provides an online registration and payment venue for products sold. Subject to section 14, the current products that are for sale are membership payments, training session registrations, and event registrations. Currently, receipts for payment of these products are provided via an email receipt and confirmation notification. Capability for printing a copy of the sales transactions is available at the time of transaction. Future products, such as books and electronic media that may be for sale will be delivered via the US Postal Service or as a downloadable file through the [ASTDTallahassee.org](http://ASTDTallahassee.org) Web site. Charges for shipping will be added to the invoice at the time of sale.

## ***17. Refund Policy***

If cancellation of a training or seminar registration should be necessary, written or email notification to ASTD Tallahassee Chapter is required five (5) business days prior to the first day of the seminar. You may receive a full refund, minus a \$50 administrative fee, up to and including the 5th business day before the seminar. If you find that you cannot attend, and it is less than five (5) business days before the start of the seminar, you may send a replacement, with written notice to ASTD Tallahassee Chapter at [vpprograms@astdtallahassee.org](mailto:vpprograms@astdtallahassee.org). If you are unable to send a replacement, you forfeit your registration fee.

Participants may transfer their registration to another seminar free of charge. The transfer request must be received in writing five (5) business days prior to the first day of the seminar for which you were originally scheduled. A \$50 transfer charge will be applied to all transfers received less than five (5) days prior to the first day of the session. Participant substitutions may be made at any time with written notification to ASTD Tallahassee Chapter. **If the substitute participant is not an ASTD Tallahassee Chapter member and the original participant was, the difference between the member and nonmember rate will be billed.**

## ***18. Indemnification***
